He provided statistics from the various social media platforms they are using. The website has reached 50,000 views. There are over 19,000 followers on Instagram and 68,000 via Facebook. City Manager Tabatha Miller gave an oral update on several items: CDBG Business Loan Programs that are currently available and that Natalie McLaughlin the Special Projects Assistant will be working with businesses to make sure there needs are met. In addition the Finance and Administration Committee is looking into creating a Fee Waiver program for Capacity Fee's. As current rainfalls cease the City is leaning towards a Water Emergency and ask for voluntary reduction of water usage. Council passed the Formula Business 45 Day

Moratorium Ordinance for the in land zone. The Fourth of July Fireworks will happened this year.
