WHEREAS, promoting and celebrating the equality and achievements of all women continues to be at the core of the 2021 celebration of Women's History Month.



RESOLUTION OF THE FORT BRAGG CITY COUNCIL

WHEREAS, the 2019 Housing Element update included several new policies and programs to guide decision makers on actions to take over the next eight years to meet housing needs of our community; and

WHEREAS, Program H-2.4.4 states: Complete research regarding Community Land Trust and consider working with community partners to establish a Community Land Trust that serves Fort Bragg; and

WHEREAS, in an effort to accelerate housing production throughout California, the State allocated grant funds to cities and counties through Senate Bill 2 (SB-2), as well as Local/Regional Early Action Planning (LEAP/REAP) grants; and

WHEREAS, the City of Fort Bragg utilized these grant funds to secure professional services to assist staff in the development of a feasibility study to better understand how the Community Land Trust (CLT) model might provide affordable housing to our community; and

WHEREAS, the CLT model appears to be an effective economic mechanism that provides a tool to set aside land and establish permanently affordable housing for very low, low, and moderate income households; and

WHEREAS, a CLT's 501(c)(3) status must be active for a two-year period before becoming eligible for Fannie Mae lending; and

WHEREAS, filing the necessary 501(c)(3) paperwork would expedite the process of establishing a CLT should Council decide to move forward; and

WHEREAS, the consultant working on this project, Dev Goetschius with Burlington Associates of Community Development, LLC, has extensive experience providing technical assistance regarding starting and managing CLTs, and has agreed to facilitate the 501(c)(3) process within the budget of their existing contract with the City; and

WHEREAS, on February 8, 2021, this item was brought forward for City Council consideration and City Council directed staff to draft a resolution, supporting the formation of a Public Benefit Corporation, recognized by the Internal Revenue Service as a 501(c)(3) under non-profit status in order to meet Fannie-Mae requirements for CLT lending as a proactive measure:

RESOLUTION NO. ____-2021

RESOLUTION OF THE FORT BRAGG CITY COUNCIL CONFIRMING THE CONTINUED EXISTENCE OF A LOCAL EMERGENCY IN THE CITY OF FORT BRAGG

WHEREAS, California Government Code section 8630 empowers the Fort Bragg City Council to proclaim the existence of a local emergency when the City is threatened or likely to be threatened by the conditions of extreme peril to the safety of persons and property that are or are likely to be beyond the control of the services, personnel, equipment, and facilities of this City; and

WHEREAS, California Government Code section 8558(c) states that a "local emergency" means the duly proclaimed existence of conditions of disaster or extreme peril to the safety of persons and property within the territorial limits of a city; and

WHEREAS, COVID-19, a novel coronavirus causing infectious disease, was first detected in China in December 2019 and has spread across the world and to the United States. Symptoms of COVID-19 include fever, cough, and shortness of breath; outcomes have ranged from mild to severe illness, and, in some cases, death. The Center for Disease Control and Prevention (CDC) has indicated the virus is a tremendous public health threat; and

WHEREAS, on March 13, 2020, the President of the United States issued a proclamation declaring the COVID-19 outbreak in the United States as a national emergency, beginning March 1, 2020; and

WHEREAS, the Governor of the State of California and the Public Health Officer of the County of Mendocino have both issued Shelter-in-Place orders to combat the spread of COVID-19; and

WHEREAS, on March 17, 2020 the City Manager, as the City's Director of Emergency Services, issued Proclamation No. CM-2020-01 declaring a local emergency as authorized by Government Code section 8630 and Fort Bragg Municipal Code section 2.24.040(B); and

WHEREAS, at a special meeting on March 24, 2020, the City Council of the City of Fort Bragg adopted Resolution No. 4242-2020, ratifying the City Manager's Proclamation declaring the existence of a local emergency; and

WHEREAS, at a special meeting on April 6, 2020, the City Council of the City of Fort Bragg adopted Resolution No. 4245-2020 by which it continued the local emergency; and
