AGENDA ITEM TITLE: Candidate Statements and Questions

The City Council has scheduled a Special Meeting for February 16, 2021 at 5:30pm to conduct interviews for the vacant City Council seat and to consider appointment of a new City Councilmember. The City Council Appointment Ad Hoc Committee was tasked by the full Council to develop five questions that would be asked of each candidate.

At the February 16, 2021 Special Meeting, each Candidate will be allowed up to five (5) minutes to make a statement about themselves. The statement may include how long the candidate has lived in Fort Bragg and their ties to the community; where the candidate is from originally (if applicable); career and work history; education; special interests including hobbies or distinct talents; and why the candidate is interested in serving on the City Council.

Every candidate will be asked the following questions, in a random order, and allowed up to one and a half minutes (90 seconds) to answer.

- 1. What previous job experience or skill set do you have that you think would benefit the City Council if you are appointed?
- 2. What do you think are the top three (3) issues confronting the current City Council? And have you attended any recent Council meetings to learn what's current?
- 3. Let's say the entire Mill Site south of Redwood is suddenly bought up by, for example, a Walmart Superstore, Disneyland, or to serve as an Amazon warehouse... What do you think your role will be as a City Councilmember from that point forward?
- 4. Explain the pros and cons of our current Council Committee system as you understand it. Which committees are you interested in serving on, and why?
- 5. How do you think other people see you?

After the pre-set questions are asked and answered, each City Councilmember will have an opportunity to ask a few followup questions of all candidates or of a specific candidate. The expectation is that these questions and answers will be brief to clarify points raised in the application materials, the candidate statement or in answers to the pre-set questions.

Finally, prior to and during the meeting, the City Clerk will gather potential questions from the members of the public through email to jlemos@fortbragg.com. The proposed public questions will be provided to the City Council Appointment Ad Hoc Committee during a brief break from the meeting and the Ad Hoc Committee will select approximately three questions to pose to all of the candidates. Candidates will be allowed up to one and a half minutes (90 seconds) to respond.

The public questions will be followed by public comment, which will be limited to one and a half minutes (90 seconds) for each individual member of the public.

The City Council will then have an opportunity to deliberate in public and discuss the candidates and possible nominations. City Council members may nominate a candidate and, subject to a second nomination, a roll call vote will be taken. The successful candidate must receive at least three of the four Councilmember affirmative votes.

While the City Council anticipates that the above process will be completed during the special meeting on February 16th, Thursday February 18th at 6:00pm has been reserved for a continuation of this special meeting, if needed.

Councilmember Eligibility, Requirements & Public Disclosure

To be eligible to be appointed to the Fort Bragg City Council, candidates must be:

- a. At least 18 years of age;
- b. A citizen of the state of California;
- c. A resident of Fort Bragg residing within the City Limits;
- d. A registered voter in the City of Fort Bragg; and
- e. Not convicted of designated crimes as specified in the Constitution and laws of the state.

- Once a Councilmember application is filed with the City, it is a public record available to the public.
- The applications received from all candidates who meet the minimum requirements will be posted on the City of Fort Bragg, CA website as part of the Council's agenda packet the week of the initial interview.
- If appointed, you will be required by state law to file financial disclosure statements

City Council Duties & Compensation

The City of Fort Bragg, CA operates under the Council-Manager form of government. The five-member City Council serves as the legislative body of the City. The Council is responsible for setting policy, adopting the biennial budget, adopting laws, determining the services to be provided and the funding levels for those services, and appointing citizens to its advisory boards and commissions.

The duties of a City Councilmember will likely involve an average minimum commitment of 5-10 hours per week for preparation, participation, and attendance at various meetings and community activities. Beyond the broad duties previously mentioned, Councilmember duties include, but are not limited to:

- Attendance is required at regular City Council meetings, which are held bi-monthly generally on the 2nd and 4th Mondays, from 6:00 pm to 10:00 pm or earlier if business is completed. From time to time, the City Manager or Mayor may call special City Council meetings to conduct city business. Meetings are virtual at this time, due to Covid-19 restrictions to in-person attendance.
- Councilmembers are expected to serve on Council Subcommittees, regional boards and commissions, and to represent the City Council at various community functions. These various meetings and functions occur normally during the evenings, but may also occur on some weekends, and during some weekdays.
- Depending on committee participation, some travel may be required locally and/or within the County of Mendocino, involving various organizations of which the City of Fort Bragg is a member. Councilmembers may also at their discretion travel and attend training, education and/or participate in other organizations at the local, regional, state, or in some instances on the national level. Travel, education, and training expenses for local, regional, state, and national activities are reimbursed in accordance with City policy applicable to all employees and city officials, subject to the budgetary limit set for each Councilmember and for the City Council as a whole.

All Councilmembers receive health benefits for themselves and their dependents and a \$300 per month stipend. An extra \$100 per month will be paid to Councilmembers if Municipal Improvement District business is discussed during any meeting(s) in that calendar month.

Dear City Council Members,

My name is Katherine A. (Kathy) Hart, Ed.D., and I'm applying for the position of City Councilmember. I recently moved to Fort Bragg as a resident in January 2019. It is a dream come true to live in this city, wrought from my first camping trip in 1975. In answering your application question, Why I want to join the City Council, I explain my personal history and interconnection with the town since I was 12 years old.

I believe Fort Bragg is at a precipice in time, poised and waiting for an undetermined future. There is significant community struggle right now, trying to discern this city's future, honoring its past, and emerging from the COVID-19 pandemic. Yet beyond those challenges, there is the even bigger question of how does this city thrive? What enables it to be a beacon of hope and promise, to thrive, grow and develop for future generations? I certainly don't have the answers, but I do have some thoughts.

First, I believe the people of this community are its hope for the future. Our job as City Councilmembers' is to actively engage and involve them in this journey. This is now, more than ever, so profoundly apparent. I have been heartened by the opportunity for comment during the public meetings, but know that we can do an even better job of engaging diverse voices, bringing forth diverse perspectives and thoughts, and finding common ground amongst the diversity of our community to navigate our way forward. I have been involved in the City of Alameda, coaching and teaching others to facilitate city-wide forums and focus groups to tackle intractable issues. I have seen the power of community coming together that can be achieved.

Secondly, I believe in the power of creativity and ingenuity. Our country and this town were steeped in the creativity and ingenuity of harnessing the resources of the area (lumber and fishing) to grow and develop. We can take immense pride that our labor and lumber served to re-build the City of San Francisco after the devastating 1906 earthquake.

Going forward we have to discern how to harness that knowledge in a more productive and environmentally focused way. Our Noyo Center for Marine Science leads the way with deepening our knowledge of how to care for the ocean. Yet there also have to be more creative and entrepreneurial ways for our community to do even more. This is where I believe the City Council can play a significant role. We can actively learn some of the ideas of people have for how to grow and develop our City. We can determine how to support our community in making their dreams a reality, all the while benefitting them personally as well.

We face a deep economic disparity in our town. We are going to have to figure out how to offer affordable housing and an economic livelihood for residents who live here, as well as offer glorious vacation opportunities for those visiting the area. These are not incompatible, yet there will always be a tension between them. When we focus too much on one, we lose sight of the other. Continuing to balance this precarious position continues to be our Achilles Heel.

And, to this end, we need to figure out how to more quickly engage and involve those who are new to our community. They are the lifeblood for the future of our community. The new residents, who don't simply choose to visit here, but want to move here permanently. APPENDIX 3 Answer to Question #2 of the City Councilmember Application

Why are you interested in serving as a City Councilmember?

To answer this question I must go back to my childhood and earliest introduction to Fort Bragg and its community.

When I was about 14 years old (maybe 12?), my mom (a single parent), along with another single parent with kids, brought me and my younger brother to Fort Bragg for a first-time camping trip. It was the beginning of my long-term love affair with the Mendocino Coast, and Fort Bragg in particular. Already I had a love of the ocean, as my parents were sailors (a hobby) even before I was born.

As part of that initial trip, my mom paid for a round-trip adventure on the Skunk Train. This was approximately 1974, when the Skunk Train traveled all the way to Willits and back again. While on the train, the three of us started to sing "I've Been Working on the Railroad," thoroughly enjoying the scenery. At the end of the song, someone leaned over and said, "Your daughter should get up and lead us" or words to that effect. As my mother would later share, your natural born leadership shone through. You jumped up to lead everyone in song. Soon you were serving as a guide, pointing out sights and landmarks along the way that you had read about before we boarded the train.

That thrill of camping and being in this logging town burrowed its way into my being. It took another 12 years for me to come back to Fort Bragg, though not much had changed. It was a different trip and I saw it through the lens of an adult, but that first camping trip and Skunk Train ride was forever a part of me. From that year on, it was a family pilgrimage to come to Fort Bragg at least once a year (and sometimes 2 to 3x a year), camping at MacKerricher State Park, eating clam chowder at Cap'n Flint's, exploring the town, picnics on the beach, attending local concerts and plays, and reveling in the community.

When I was 29, I explored the opportunity of buying a place in town to serve as a 2nd home. I met with a Real Estate agent, toured homes, and decided that I could swing the financials, with my mother's help. As a mother-daughter love of the Coast, we dreamed of coming here and becoming more integrated into the community. As life does, mine took a turn and I took a position in Southern California.

When I met my husband in 1997, after moving back to the Bay Area, I shared that I couldn't marry anyone who didn't love the California coast, and in particular Fort Bragg. My husband Paul laughed at the time, sharing that he too went camping as a young child with his parents at the Van Damme State Park. He really enjoyed Mendocino. I was quick to point out there was a distinct difference between Mendocino and Fort Bragg. He could certainly enjoy Mendocino, but his loyalty would have to be with my town of Fort Bragg. We were married in Jan 15, 2000. We continued the family tradition, along with my mom and various family and friends, of at least 1 -3 camping trips in the summer, adding on a couples retreat every January. My husband grew to love Fort Bragg as much as I did.

When I began my consulting company, ClearVision Consulting, Inc., the stockholder's annual meeting address was for Cleone Gardens Inn. It was another reason to come to the area.

As my mother became more enfeebled and couldn't travel as much, she seemed to perk up every time we traveled here. No longer camping, we stayed at Cleone Gardens Inn, so close to the MacKerricher day-use beach. She would sit on the back porch, listening to the ocean, and we would reminisce about childhood and family gatherings. She asked that when she passed we secretly scatter some of her ashes in the ion-filled Pacific Ocean, forever among the beach she so loved. The family joke was every time we

arrived at the beach, my mother would yell for everyone to "breath deep" from the ions in the ocean. According to her, they would carry us forward health-wise for at least another six months.

Over the years my husband and I debated quite a bit about buying a 2nd home here, even taking actionable steps to meet with a Real Estate agent and explore properties. Yet there always seemed to be another financial need that cropped up. It wasn't until several years ago (2018) that our dream turned into reality.

My husband retired early and I morphed my business to a phone/electronic based coaching services. We traveled extensively for several years, living for 2 -3 months in Ireland, Scotland, and Mexico, discerning if we wanted to buy a retirement home abroad. On one return trip home, we realized living abroad permanently was not our destiny. It's when we looked at each other and understood that all along, we were being pulled toward the city we both called our 2nd home, Fort Bragg. We made that decision in May of 2018, and by the end of June we found our home at 119 Jewett Street.

My husband and mother-in-law traveled here to see the house, but I couldn't as I was working. I bought my house from a Zillow ad and my husband's comment, "Honey, its home." Later I would learn that we had purchased the home of former Mayor Jere Mello, who had rented it out when he married his wife Madeline. Memories of that summer when we almost had to cancel our trip due to a manhunt in Fort Bragg would later emerge.

We bought our house in July 2018, but rented it for six months while we completed already planned for travels. It was early Jan 2019 that we moved in and truly called ourselves residents of Fort Bragg. It has been our joy and delight to make personal friends in the area, enjoy the recreational trails, and deeply explore the city.

For the last year, during a house remodel, knee replacement surgeries, and a COVID-19 pandemic, I have been reflecting on the next step in my life journey. This has been spurred on because I am turning 60. I know my way forward lies in the realm of public service, what I haven't been so clear on is where to focus my energy and bring a wealth of knowledge and skills to help others.

When I learned of the open position as a City Councilmember, I was intrigued. Perhaps this could be an opportunity to give back to a community that has been part of my growing up and my future. This town is a link with the child I was, my mother and dear friend, whose ashes are scattered before me in the ocean, and my future Third Act as a senior with wisdom, energy and a deep understanding of the need for community to come together, grow and develop, and re-imagine the future.

I believe the City of Fort Bragg is currently at a pivotal time in its history. It's dealing with societal unrest, attempting to honor its history and legacy, but also trying to understand what its future can and should be. It is faced with the huge challenges wrought by COVID-19, deep economic disparity within the community and an uncertainty of what the future holds. On the other hand, its people are resilient, have shown a true sense of community spirit during last year's electric outages, and there are people, like myself, who love this area deeply and profoundly. Why do I want to join the City Council? I want to work with the community of Fort Bragg in a more personal and profound way to navigate a future that enables it to thrive and shine as the jewel on the Mendocino Coast.

What strengths would you bring to the Council?

In addressing this question, I believe it's actually a two-part answer. Strengths, as in those identified by different personality assessments (e.g. Myer Briggs Type Indicator®, Social Style®, and CPI 260®), vs. skills and knowledge, which have been developed during my youth and career.

Strengths – Personality Assessments

- On the extrovert/introvert scale, I am a higher as an extrovert (though not gregarious) than an introvert. I enjoy connecting with people, and get energy when people are engaged and involved. Reaching out and talking to people on the telephone, in-person and in group meetings brings me energy. Though I have learned in my personal leadership development and growth that when I allow for quiet time and reflection, my energy levels for understanding and discernment are heightened.
- Deeply analytical, relying on data, talking with people, and research/reading to make sound decisions. There are many individuals who are intuitive in their thinking and understanding. They make decisions from their gut, how their body feels, etc. I so admire this trait at times, because it is not typically how I operate. For me to understand and make a decision, I need to talk with people, understand the nuances from their perspectives, read, and know the analytics/data behind the potential results, before I am ready to make a decision. Through experience as an investigator and business owner I've had to learn how to quickly analyze data, make a decision, and adjust as new information unfolds.
- In almost all personality indicators I am very high in the leadership (take charge) trait, but also with a focus on relationship orientation. How this gets manifested is in the ability to build up and support others, looking for opportunities where diverse perspectives and voices can contribute.
- Big-picture (strategy) focused, in that I enjoy thinking out and planning several years in advance, with a combined extreme focus on the details and tactical follow through. It serves me well, especially when working with people who are more oriented to one or the other. I have the ability to understand and realize how to approach individuals in their comfort level, and then switch to the other when needed.
- Continuous learner, along with a strong belief in continuous improvement. Through books, education and insights from others, I strive to continuously grow and develop myself. Yet I also strongly believe that people, processes, systems can be improved upon. I am always looking for the opportunities to move forward, while engaging and involving others.

Strengths - Skills and Knowledge

- Engage in and involve others through active listening. As a former disaster response provider, investigator in occupational safety and health incidents and a long-time instructor, I learned early on how to ask discerning questions to understand what people are thinking and why they take the actions they do. Because of an interest in conversation and dialogic/group interactions, my dissertation had a basis in interpersonal communications. I have also taught for many years the nuances and skills of how to actively listen, including: mirroring, paraphrasing, and drawing people out. This knowledge of active listening has also served to strongly increase my ability to influence and support people in shifting an entrenched mind-set and behavior patterns.
- I am exceedingly articulate in my speech, both in 1:1 conversations, but also in my understanding
 and knowledge of group dynamics and how to facilitate large groups of people. Since early on in my
 career the dynamics of how people operate when you talk with them individually and the shift that
 occurs when they are with others has fascinated and intrigued me. I have spent several careers
 honing my skills in this arena. I quickly know and, from trial by fire, can coordinate large groups that

are seemingly in tractable positions, and afford them the ability to find common ground and reach a decision that all can agree upon.

- Since elementary school, when my mom and minister asked me to stand in front of the church and ask for people to pledge their time, treasure and talent, I have enjoyed speaking in front of large groups. In high school I participated in local and regional speech contests, and was selected by my high school to deliver one of two prepared graduation speeches. As an adult this young adult skill was honed speaking before: corporate executives, front line employee groups, union leaders, and learners of every age. When I started my management consulting firm I learned how to price my speaking ability. Early on it became a money making opportunity for me, both as a public speaker, but also in coaching others to grow and develop as public speakers.
- I started in the field of disaster preparedness when I was 15 ½, needing to learn CPR and First Aid as a lifeguard and swimming instructor. I became an instructor a year later through the American Red Cross (ARC), since I was not impressed with my previous instructor. This interest led me to volunteering with that organization in emergency preparedness exercises, and later becoming an instructor in Earthquake Preparedness. When I graduated from college and moved to San Francisco I was identified as the ARC, Golden Gate Chapter, volunteer on-call emergency responder for evening events, from bomb threats, 2-alarm fires and larger and other emergency —type events. 



To go door to door during Covid and hear the concerns locals have or go to their businesses is not an easy task either at the current time. Mary Rose Kaczorowski has done that already the last time we needed new Council members. She would have gotten a seat on the Council if the Council would have needed 4 new members instead of only 3, as she was 4th. She in her last job as a census worker also got a deep understanding of the local communities.

I have attended many Council meetings especially in regards to appropriate land use and participated extensively at these meeting through my oral and written comments over the last 5 years. City Council Duties & Compensation

The City of Fort Bragg, CA operates under the Council-Manager form of government. The five-member City Council serves as the legislative body of the City. The Council is responsible for setting policy, adopting the biennial budget, adopting laws, determining the services to be provided and the funding levels for those services, and appointing citizens to its advisory boards and commissions.

The duties of a City Councilmember will likely involve an average minimum commitment of 5-10 hours per week for preparation, participation, and attendance at various meetings and community activities. Beyond the broad duties previously mentioned, Councilmember duties include, but are not limited to:

- Attendance is required at regular City Council meetings, which are held bi-monthly generally on the 2nd and 4th Mondays, from 6:00 pm to 10:00 pm or earlier if business is completed. From time to time, the City Manager or Mayor may call special City Council meetings to conduct city business. Meetings are virtual at this time, due to Covid-19 restrictions to in-person attendance.
- Councilmembers are expected to serve on Council Subcommittees, regional boards and commissions, and to represent the City Council at various community functions. These various meetings and functions occur normally during the evenings, but may also occur on some weekends, and during some weekdays.
- Depending on committee participation, some travel may be required locally and/or within the County of Mendocino, involving various organizations of which the City of Fort Bragg is a member. Councilmembers may also at their discretion travel and attend training, education and/or participate in other organizations at the local, regional, state, or in some instances on the national level. Travel, education, and training expenses for local, regional, state, and national activities are reimbursed in accordance with City policy applicable to all employees and city officials, subject to the budgetary limit set for each Councilmember and for the City Council as a whole.

All Councilmembers receive health benefits for themselves and their dependents and a \$300 per month stipend. An extra \$100 per month will be paid to Councilmembers if Municipal Improvement District business is discussed during any meeting(s) in that calendar month.

Mr. Mayor and Members of the City Council,

I am writing to ask for your vote in support of appointing me to the City Council. I know that you are all familiar with me, as I have attended City Council meetings, addressed this Council both in person and in writing on numerous occasions, and served on the Election Systems Review Committee, among other interactions.

I believe my involvement with this Council, and City issues in general, makes me an excellent choice. I do, however, feel the need to acknowledge that my position on certain issues - beginning with the 2016 City Council election, in which I ran against Mr. Norvell - has put me at odds with individual council members on occasion. In this regard, I implore you to consider my application without bias.

It is easy to get caught up in arguments about ideology and partisan politics, so I think the best way to make my case is to submit to you a vision for Fort Bragg. This vision is not a radical re-creation of our town, but rather a strengthening of the qualities and values that we already have, achievable through creative and effective policies.

The vision of Fort Bragg I hold to is one in which the town's vibrancy is a person's first-impression. Our historic downtown is thriving and filled with unique mom-and-pop businesses. These local, independent businesses are better protected from the predatory business practices of online retailers and formula/corporate chains and franchises, ensuring higher quality local jobs and a stronger local economy. The Old Town buildings are restored, preserved, and in good, safe, working order. More of the downtown business owners own the buildings they're in, thanks to a Commercial Space Land Trust that makes it affordable to do so.

Through a City financing program, all the buildings in the Central Business District have been retrofitted with sprinkler systems to protect the entire city from the ever-increasing fire danger. Creative parking and traffic solutions have been implemented to improve the safety and flow of traffic on Main St. and have made the 300 block of Franklin St. pedestrian-only, with street vendors, outdoor dining, and open-air concerts adding to Old Town's exciting street life.

The Mill Site is clean and carefully redeveloped so that commercial enterprises on the site do not siphon economic vitality away from Old Town. Maple and Alder creeks have been "day-lighted" and restored within the public, open space on the Mill Site. Creative, adaptive reuse of defunct Mill Site infrastructure places Fort Bragg at the forefront of brownfield reclamation (e.g., turning the concrete wall by the Coastal Trail into a world-class rock-climbing wall). A portion of the land has been returned to the Pomo, granting them exclusive Native rights to their ancestral fishing grounds.

There is sufficient affordable housing due to City efforts to encourage infill construction and low-income housing projects. There are few visible homeless folks, because they have been provided with housing and supported in establishing sobriety, physical and mental wellness, and employment whenever possible.

Improvements to the local voting system have resulted in the residents of Fort Bragg feeling more engaged and satisfied with their local elected boards. Voters believe their vote represents their values. The Council reflects the actual political and demographic cross-section of the community, resulting in more diverse representation.

If this vision for our town resonates with you, I humbly ask you to let me join you in your efforts to guide us there.

2. Why are you interested in serving as a City Councilmember?

As I illustrated in my cover letter, I believe that certain practical and tangible changes can lead to increased vitality and stability in our economy and a higher quality of life for all of our residents. I ran in 2016, and am applying now, because I believe I have a lot to offer. I care deeply about making our world a better place for everyone, including the flora and fauna with which we share this planet. This means finding ways to encourage thriving as well as addressing sources, systems, and politics of oppression and exploitation.

Living in a remote, rural area can sometimes lead us to feel like we are on an island, but we do not, in fact, exist in isolation. The forces that affect us are inextricably tied to a bigger picture. I want us to examine that big-picture and leverage the ways in which our smallness and remoteness could give us a greater advantage in making our local community and economy the best it can be. We must begin to look at the ways in which our local issues intersect with the most pressing national and global issues, such that we can identify the ways that Fort Bragg can thrive while being a small-town leader in progress, justice, and sustainability.

A high level of commitment to the office is critical, and I have demonstrated my commitment by remaining engaged in City politics, even after I lost my election run. I am making this decision because I know why I want to serve and what I am getting into. I also have the ability at this time to make serving on the City Council my top priority.

3. What strengths would you bring to the Council?

I am acutely aware of the challenges to our local businesses, especially now, as I made the heart-wrenching decision to close my martial arts studio (though not my business) last year, due to the pandemic. Every town, especially a town buttressed by tourism, needs a vibrant downtown to anchor the community. But our downtown is visibly suffering. Buildings are in disrepair, rents are high, foot-traffic is low, parking can be a challenge, the needs of residential tenants and commercial tenants are frequently in conflict. Few business owners own the buildings in which they reside. These realities plus the external pressures of online goods, services, and even jobs (not to mention the pandemic) have pushed our local downtown economy to the brink.

I spent years exploring the role of small, independent businesses in community development. My work establishing an Independent Business Alliance in Humboldt County and my involvement in the Fort Bragg business community have all affirmed my belief in the power of small, independent businesses to grow social capital, develop our economy, and effect social change. Mom-and-pop businesses as sites of community-building was the topic of my Master's thesis.

I am concerned about Fort Bragg's voting system and the potential for additional lawsuits regarding the City's compliance with the California Voting Rights Act (CVRA). The fact that this council has decided twice, in the past five months, not to hold an election, and that there were no challenges to the incumbents in this past election, even though the City has adopted various measures to encourage participation, are worrisome trends. I have demonstrated knowledge of multiple voting systems. I have been involved off and on in both election reform and election integrity advocacy for over 15 years, including being a core volunteer for the original Humboldt Election Transparency Project, "a project that started in Humboldt in June 2008 [which] utilizes the right to view all ballots cast in a race to perform a citizen recount after every election in the county." (https://electionstransparencyproject.com/) I believe that my appointment would speak to the integrity of this Council in considering the seriousness of the CVRA lawsuit and terms of its settlement.

As a long-time community organizer, I know how to get people engaged and organized around an issue. I believe that the experience and insight I have gained while running my own City Council campaign, staying abreast of City issues, creating petitions, and organizing with hundreds of diverse folks in our community would be an asset to this Council.

I have a fierce commitment to honesty, fairness, and justice. I take who I am as a person very seriously and put extensive effort into developing myself in terms of character and emotional intelligence. I am perpetually working to become a better person and community member. I demand evidence for claims, both mine and others'. I am open-minded to creative thinking, strategic solutions, and evidence that challenges my position. I am committed to the careful consideration and balance of the conflicting missions, needs, and realities that come with every issue.


